General Product Description:
Changes to the Secure Copper RJ45 Product Offering

Description of Changes
The orange and violet color/keying option will be eliminated from the Secure Copper RJ45 product offering both for unshielded and shielded patch cords and also unshielded and shielded jacks. The entire field-installable Secure RJ45 modular plug kits will be discontinued. An enhancement will be made to the Secure unshielded and shielded patch cords by using a transparent slim-line boot allowing the patch cords to be used in high density applications.

Reason for Changes:
Part status change. After having the Secure Copper RJ45 product line available in the industry for over 10 years, it has become apparent that the industry has a need for only 4 colors/keys. We will continue to offer the 4 colors/keys commonly requested (red, blue, green and yellow) for both the jacks and patch cords. Additionally based on sales it had been determined that the industry prefers to purchase Secure patch cords versus making their own patch cord from modular plug kits and for this reason we are discontinuing them. Lastly the new transparent slim-line boot is being used with the Secure patch cords to harmonize with our other patch cord offerings and offer customers a high-density solution if needed
